

## Coast Guard Finds Body of Vermontville Man

The body of Captain Donald Hayward, 55, which has been missing since January 13, 1951, has been found in Lake Erie by the coast guard, Mrs Velma Whittmore of Grand Ledge, his cousin, was notified this week.

Hayward formerly lived in Vermontville.

Hayward lived alone on the SS Crawford, which was docked at Ashtabula, Ohio for the winter. It is believed he fell overboard on Saturday, January 13. Other members of the crew, which were away for the weekend, did not find that he was missing until the following Monday.

His wife, Tillie, lives in Buffalo New York.

## Mrs. Gladys Doty Dies here Tuesday Burial Services Set for Friday at 2:30

Mrs. Gladys Doty, 62, died of a heart attack at the residence on Bridge street Tuesday morning at 8:50 o'clock. She had been confined to her bed most of the time since the seventh of last October when she suffered a stroke. The police department rushed the inhalator to the home when she suffered the heart attack but was unable to be of any assistance.

Funeral services will be held at the Peters Funeral Home Friday afternoon at 2:30 o'clock and burial will be in Oakwood cemetery.

Mrs. Doty was born December 19, 1888 in Vermontville the daughter of Inez and James Walsh. Her family moved to Grand Ledge in 1910, while Gladys was teaching school in Traverse City. She came here in 1912 to be with her family and to teach in the public schools.

On June 30, 1915 she was united in marriage to Mark Doty which was the year he opened the Doty Greenhouses. They observed their 25th wedding anniversary in 1940 with open house.

She was active in several clubs. She was a Past Matron of Chapter No. 14 O.E.S. and was re-elected to the office of secretary of that organization shortly before she became ill. She was unable to be present at the installation. She was a member of the Past Matrons club; the A.B.C. club, where she served as president in 1920-1921; the Garden Club; I. T. Club; past president of the Congregational Women's Fellowship; and a member of the Congregational Church.

Survivors are the husband, Mark; one daughter, Mrs. Janet Thompson; one son of Hastings; one son, Dean of Grand Ledge; four grandchildren; one sister-in-law, Mrs. Edna Walsh; and several nieces, nephews, and captured cousins.
