Karl R. Weiler born in Sandusky County, Ohio, Oct. 27, 1893 and died at Kalamazoo Hospital Dec. 8, 1965 at the age of 73 years.

He was the oldest son of Charles and Ida Weiler. Karl was married to Alma Radtke in 1914 and came to Michigan starting in Eaton County as a clerk in a Charlotte store. Later he had the Chevrolet dealership in Vermontville for many years. He has been a prominent businessman in Eaton County since 1918.

Mr and Mrs Weiler had two sons, Nyle Karl who died in 1945 at the Naval Hospital in Oakland, California; Dick Robert who resides at the family home in rural Vermontville with his wife and 3 children. Karl is survived by his wife Alma, his son Dick and two brothers, Oliver Weiler and Walter Weiler of Vermontville and 3 grand-children.

Mr Weiler was very active in Civic Affairs, Lions Club, Boy Scouts, Red Cross, United Health and Welfare, Maple Syrup Festival and others.

He was Secretary & Director of the office of Civilian Defense for Eaton County during World War II. He was the National Farm Census Supervisor for six counties during 1945.

He has been affiliated with the Congregational Church of Vermontville all of his life.

Henry A. Wallace Succumbs at 77 In Connecticut

WASHINGTON (AP) — Henry Agar Wallace, former vice president, Cabinet member and presidential candidate, died today at the age of 77, his son-in-law said.

The son-in-law, Washington broker Leslie Douglas, said Wallace died at a Danbury, Conn., hospital.

He said Wallace was taken there this morning from his home in South Salem, N.Y.

Wallace had been hospitalized at the National Institutes of Health in Washington. He was released from that hospital on Oct. 28 and returned to his farm home.
