

Former Mayor Of Grand Ledge Succumbs at 85

GRAND LEDGE—H. Marr Byington, 85, Grand Ledge, prominent public servant and businessman, died Friday in a Lansing hospital. He had been hospitalized about six weeks.

Mr. Byington was a former mayor and city treasurer of Grand Ledge, relief administrator and member of the relief commission for Eaton County, and a member of the first board of directors of Hayes-Green-Beach Hospital, Charlotte.

He was Grand Ledge postmaster from 1935 to 1950 and instrumental in getting a new post office here in 1939.

Byington was a life member of Masonic Lodge No. 179, and until his death was its oldest living past master. He joined the lodge in 1901.

He operated a shoe store here 35 years, was a graduate of Albion College, and a member of Delta Tau Delta Fraternity and the Congregational Church.

Survivors include the widow, Cora; a son, Ford of Grand Ledge; a brother, Dr. G. M. Byington of Los Gatos, Calif., and a grandson.

Services will be at 2 p.m. Monday at the Peters Funeral Home here. Burial will be in Oakwood Cemetery.
