SEVERAL MEN BURNED UP.

There are more bodies but as we go to press are as yet unidentified. It is reported (on allegation) that two men are in jail in Hastings for questioning regarding the fire, also to account for the loss of about \$500 worth of furs alleged to be missing from the house. Several of the party were in Nashville earlier in the evening buying oysters etc. for a New Years meal. It is alleged that several of the party had been drinking, which may or may not account for the loss of life.

The fire started about midnight and the coroner arrived about three o'clock this morning and is doing his best to recover and to indentify the other bodies. When the cellar cools off more will be found no doubt. The loss of life may run as high as eight or ten.
